SAFETY PLAN TO PROTECT VIOLENCE

•Stay away from places where there are cutting and piercing tools in the house, especially bathrooms, kitchens, and places where your feet might slip as much as possible. Be in areas that give you the opportunity to move. In case of violence, do not close yourself to places such as bathrooms, kitchens, be near the exit door as much as possible.



•Shout loudly in case of violence. You can get support and have your neighbors witness.

•If you think you will be subjected to physical violence, you can share it with a neighbor you trust. Whenever you need help, you can notify it with a pre-determined sign. Your neighbor can call the police. (Under our law, anyone can report violence; they do not have to provide identification information when reporting.)



•Keep the phone numbers you can reach and get support with or save them to your phone so that you can call them with one touch.

•Download the KADES (Women Support Application) application to your phone. In case of violence, your report will reach the police directly and you will be able to get help.



•Find a safe place for your children (a room with a lock, a neighbor's house). Talk to your children, "Your job is to be

safe, not to protect me."

•Prepare an easily accessible emergency bag. Keep this in the home of a trusted friend or neighbor. You can put the following in the bag: ° Documents (or photocopies) of you and your children such as ID, driver's license, birth certificate or passport ° If you are a foreigner (and if any), residence permit, work permit ° Some money, credit card ° SSI information or private health insurance information ° Medicines that you or your child regularly use, if any, ° Clothing belonging to you and your child ° Your item that you can sell at a light price, if necessary, ° Any document or injunction taken from the court ° Documents related to the existing property (house, land title car license) or a copy of the lease ° Spare keys of the house and car ° Phone charging



• If you have decided to leave the house, do so when you are most safe. Plan at what time, which door or window you will exit, and what steps to take next

LEGAL PROCESSES TO FOLLOW IN CASE OF VIOLENCE

The Istanbul Convention, Law No. 6284 on the Protection of the Family and the Prevention of Violence Against Women opposes violence against women. You can get the following supports under the relevant laws.

You can apply to the police station or prosecutor's office when you are subjected to all kinds of violence. The law

enforcement (police/gendarmerie), which receives the application or the notification, will make an investigation into the crime and deliver the documents to the prosecutor's office. Also, if domestic violence is detected, it will refer the file to the Family Court for a protection order without any complaint requirement.

The prosecutor's office may decide to file a criminal case with the evidence collected. If you are subjected to physical violence, be sure to get an "assault report" to prove the violence.

Within the scope of the Law No. 6284 on the Protection of Family and Prevention of Violence Against Women, you can be exempted from paying fees and request removal and protection in a short time.

The perpetrator is informed about the protection order issued by the Family Court. If the violent person violates the protection order, criminal action and coercion imprisonment may be imposed on him.

If your financial situation is not suitable, you can get free legal support through the legal aid services of the bar association.

You can apply to the violence prevention monitoring center in your city and settle in a shelter.

You can request to go to a shelter outside of your city. However, if you have children, boys over the age of 12 are not allowed into the shelter. He can temporarily stay in a different institution under state guarantee.
